## 2017-2018 STUDENT/COLLEGIATE AUDITIONS Missouri Student/Collegiate Auditions Fact Sheet 2018 Competition: March 10, 2018

**CATEGORIES:** Piano, Organ, Harp, Women's Voice, Men's Voice, Violin, Viola, Cello, Double Bass, Orchestral Winds, Orchestral Brass, Percussion and Classical Guitar.

### ANNUAL MFMC STATE AWARDS:

- **McHaney Award for the Student/Collegiate Auditions** - \$1,300 for the Overall Winner. Category Awards of \$100 may also be given.
- **McClure Competition Awards** - \$200 for 1<sup>st</sup> Place in Strings, Piano and Voice

**THE NFMC STUDENT/COLLEGIATE AUDITIONS** are biennial Competitions that occur in odd numbered years. The winner of Missouri's Annual Award may compete the following year to advance to the national competition. **For Rules, Repertoire, & Application form see NFMC website [www.nfmc-music.org](http://www.nfmc-music.org) Competition & Awards, Biennial Student/Collegiate Awards.**

**ELIGIBILITY, REPERTOIRE:** Entrants must be members of the Federation either through their university's membership or through Individual Membership (send \$16 dues with application for individual membership). **For Repertoire Requirements see [www.nfmc-music.org](http://www.nfmc-music.org) Competition & Awards - Biennial Student/Collegiate Awards.**

**AGE:** Competitor's Age as of January 15 in the audition year – 19 through 25

**FEES:** \$30.00 for the Student/Collegiate Auditions and the McHaney Award  
\$15.00 for the McClure Competition and Award  
\$40.00 for both competitions

**DEADLINE FOR ENTRIES:** Applications must be postmarked by January 15, 2018.

**AUDITION DATE & LOCATION:** **March 10, 2018** at the First Christian Church, 327 East Capitol Ave, Jefferson City, Missouri 65109.

### TO APPLY:

Use the **NFMC Student/Collegiate Audition Application** for the \$1,300 MFMC McHaney Award (the 2018 Winner may compete again in 2019 for the NFMC Competition).

Use the **MFMC McClure Application Form** for the \$200 McClure Awards.
